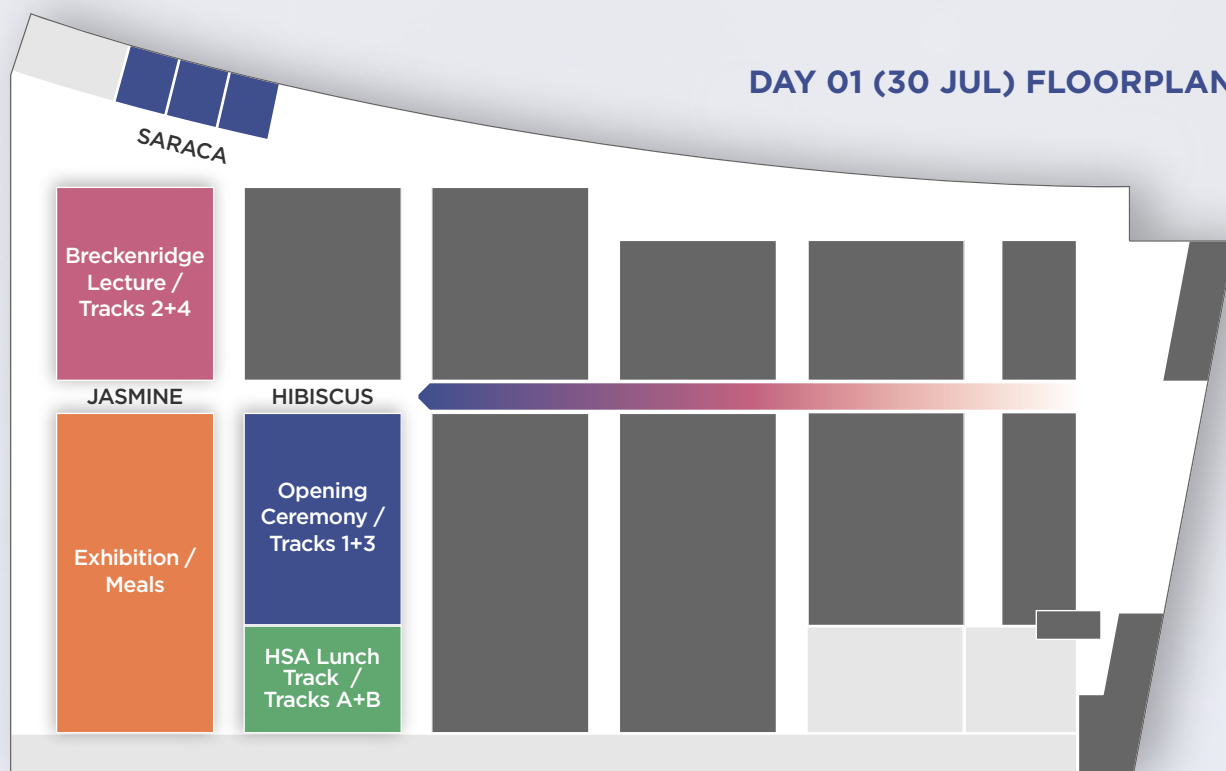

4. SCRI Academy

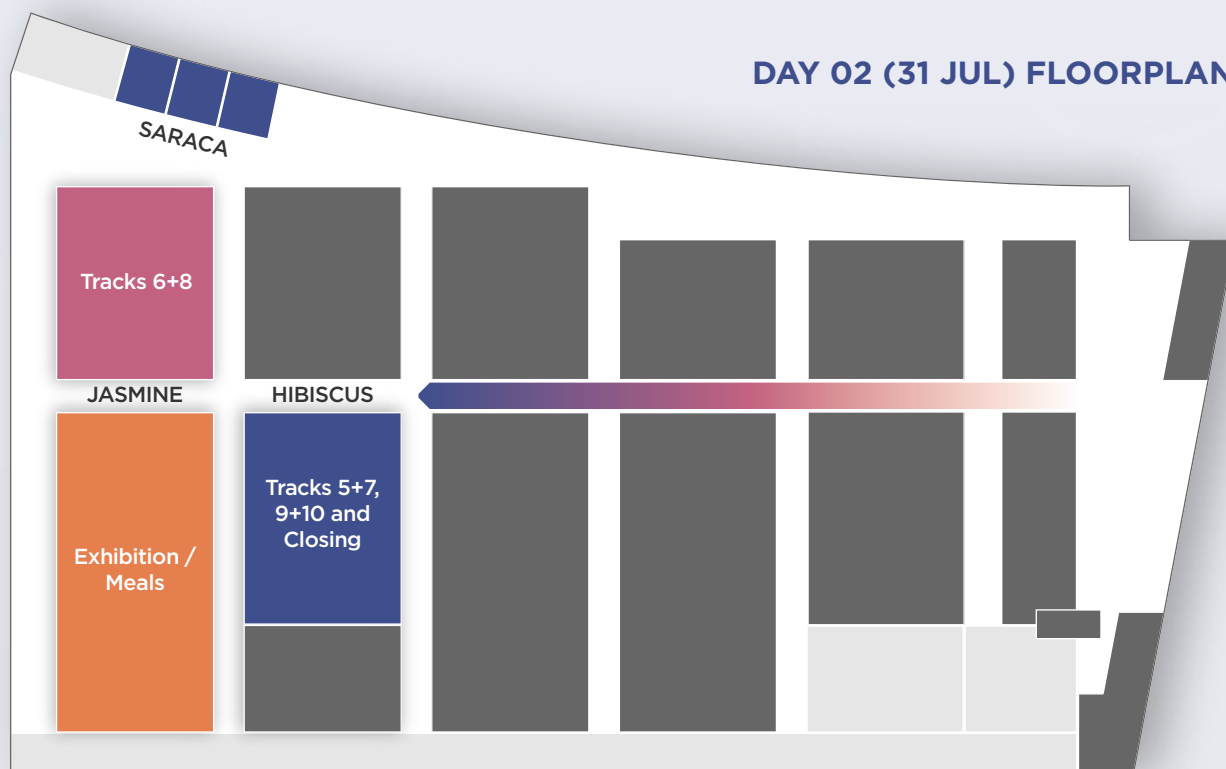

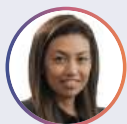

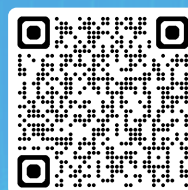
